REGIONAL MEETING

A joint meeting of New York
City and Long Island Region was
held on December 13, 1995 at the
Borough of Manhattan Community
College Conference Center. What
made this meeting so unprecedented
was that is was attended by Lucy
Wiertel, President of NYSOBBA, Jack
Edwards, NYSOBBA Conference Coordinator, Kathy Crowder, NYSHEC rep to
NYSOBBA, and that it also was held
jointly with the NYSFAA Region VI
members.

The agenda started at the Broadway Conference Room reserved for NYSOBBA members only. The meeting started with the presentation by Jack Edwards of a video of the upcoming June 1996 conference which is to be held at the Gideon-Putnam Hotel.

NYSOBBA scholarship application forms for 96-97 were distributed to each member present.

The NYSOBBA regional meeting was adjourned and moved to the Manhattan Conference Center to join with the NYSFAA Region IV members and hear the scheduled speakers.

We were fortunate to have three excellent speakers at our annual regional meeting. The guest speakers from the Department of Education were Jeffrey Baker, Director of Policy and Development, and John Skolotus, Program Analyst General Provision Branch. We also had the newly-appointed NYSHESC President, Robert J. Maurer.

After Jeff Baker reviewed the

most recent final regulations, the newly appointed President of NYSHESC, Robert Maurer presented a not very optimistic view of the future of state support for higher education.

Mr. Maurer's speech was followed by John Skolotus who reviewed the more complex points of Cash Management.

The meeting continued with Jeff Baker presenting a summary of the newly expected requirements for FAT and NSLDS. Based on his review, institutions will no longer be required to request FATs effective for 1995-96, but will be required to access the NDSLS prior to making disbursements. He also stated that even though NDSLS will be available, FAT's are still an acceptable form for determining student's eligibility. This means that even if you rely on the NDSLS to support your institution's procedure, you are still required to provide FATs to those that still rely on the previous methods.

Jeff Baker indicated that the Department of Education is working on measures that will advise colleges as to which students, who were originally reported to be in good standing, are now in default or owe a repayment.

Jeff Baker also stated that a detailed "Dear Colleague" letter addressing all these concerns should be received in the beginning of the new year.

After the meeting, we moved to a festive environment where we partied and held a raffle type grab bag sponsored by the NYSOBBA NYC region. Two of the winners of the grab bag were Bill Iannuccilli and Cathy Rehman.

I would like to thank NYSFAA
Region VI, Howie Leslie, SVA director of Financial Aid, and Cathy
Rehman, Long Island Regional Director, for helping me getting this whole thing organized.

I also wish to thank all my NYC and L.I. regional members who were able to make it to the meeting and thanks to Lucy Wiertel, Jack Edwards, and Kathy Crowder for showing up to be part of the meeting and festivities.

The State University College at Oneonta is a selective, comprehensive, state-assisted institution located in the Susquehanna River Valley about halfway between Albany and Binghamton.



- * The collection of books,




periodicals, and microforms in Oneonta's Milne Library ranks number one among SUNY's 13 university colleges.

HESC UPDATE

THE STATE BUDGET PROCESS

On December 15, the Governor submitted a State budget proposal to the legislature. Changes in State student aid programs contained in the proposal were detailed in TAP Bulletin #114. Additional copies of the Bulletin can be obtained by calling 518-473-4564.

FEDERAL INFORMATION

On the federal scene, Mr.
Maurer has appointed Peter Keitel
Chair of a Reauthorization Task
Force. Peter will contact members
of the financial aid community for
input in the coming months.

FFEL PROGRAM UPDATE

It is anticipated that the current loan program debate in Congress will result in some type of "hybrid" loan program including the best features of both the FDSLP and FFEL.

Last year, HESC's loan volume was the largest in its history, with aggregate loan volume reaching just over \$1.7 billion.

The federal budget reconciliation proposal includes reductions in Guaranty Agency income. Reductions include a loss of reimbursement for pre-claims, lower administrative cost allowances, and a reduction in default fees.

HESC's Escrow EFT process has been expanded to include 3 weekly disbursements starting in January, and daily disbursements starting in July. Recent EFT improvements include reducing fees, providing an electronic refund system, and refining reports.

GRANTS AND SCHOLARSHIP UPDATE

TAP applications are up 2 1/2% as compared to the same time last year; awards are down slightly (1.6%).

The 1996-97 TAP application process again requires completion of the TAP application and FAFSA. CSS will not be issuing a New York State-specific Financial Aid Form for 1996-97.

HESC continues to work on redesign of the TAP and Scholarship processing systems to be used for the 1997-98 processing cycle. Financial aid and business officers will meet at HESC in February to supply the G & S Redesign Team with information about ways the new automated system can meet the school's need. Topics will include the type of reports and formats needed, the schedule of report issuance, screens and on-line capabilities, and impact on processing.

Re-engineered FFEL Promotion Continues

HESC, together with a group of lenders and servicers committed to providing the best available loan process to schools, continues to promote the formula for success:

PAL + EFT + Clearinghouse

At the New York State Financial Aid Administrators Association

Annual Conference, we jointly sponsored a FFEL Room and FFEL Session. Both of theses were extremely successful in demonstrating to over 500 student financial aid administrators that the FFEL program is still the best program for their students. HESC will conduct the Re-engineered FFEL session at the June '96 NYSOBBA Conference.

The unified outreach effort will continue through October 1996 with site visits and additional products and services.

RECENT EFAN ACTIVITIES AND UPCOMING INITIATIVES

New EFAN Features:

- o Ability to process disbursements and cancellations online
- o Ability to print Application/ Promissory Notes in the financial aid office
- o Option to sort records in name order for TAP Roster and Remittance Advice
- o Ability to view and pull down available batches, and to receive batches again

On January 2nd, HESC opened its new Homepage on Internet's World Wide Web. The HESC Homepage includes descriptions of the State and Federal aid programs the Agency administer, contacts for additional information and an ability to send questions electronically to HESC information services staff. It also provides links to NYSFAAA, U.S. Department of Education, and

CollegeNet Homepages. Students can use this combination of Homepages to obtain information about available aid programs, access on-line scholarship searches, and view descriptive information about the college they wish to attend.

The HESC Homepage also includes the 1996-97 TAP application. Students can draw down the application, print it, and then complete and mail the form using the regular paper process.

PATH for Windows will closely follow the schedule set by USDE for EDE. A Windows version should be in place for 1997-98. HESC surveyed users in December to seek information about Windows usage and recommended hardware.
